## **Use of Cookies and Similar Technologies**

Like most companies we use cookies on our web sites. Cookies are small packages of information, which websites store on your computer or mobile device to make your user experience more efficient. We use cookies in accordance with applicable data protection law, in particular the General Data Protection Regulation ("GDPR"), the e-Privacy Directive and the applicable country-specific laws. There are technically essential and non-essential cookies.

### **Essential Cookies**
